TX50	Jacket: 2 bands of retro-reflective tape around the torso and each arm. 2 flapped chest pockets and contrast blue upper cuffs, lower torso, pocket flaps and front shoulders.
TX51	Trousers with 2 bands of retro-reflective around each leg. 2 flapped hip and back pockets, 2 side pockets. Contrast blue front thigh pocket flaps and around the waist and each ankle
TX52	Bib Brace Trousers with 2 bands of retro-reflective tape around each leg and 1 band across the chest. 2 flapped hip and back pockets, 2 side pockets. Contrast navy front thigh, flaps and ankles
TX55	Coverall with 2 tape bands retro-reflective tape around the torso, each arm and each leg; 2 chest pockets and 1 thigh pocket. contrast navy thighs, ankles, cuffs & waist
TX70	As TX50, but with only one chest pocket. Contrast panels to lower torso, lower arms and collar
TX71	As TX51 but with kneepad pockets included. Only one flapped back pocket, a thigh pocket and 2 side pockets. Contrast navy to the lower legs and kneepad pockets
TX72	As TX52 except retro-reflective tape has 2 bands around lower legs only, kneepad pockets included. Contrast navy to the lower legs, kneepad pockets and top of the bib.
