The garments have one band of retro-reflective tape sewn on encircling the torso with over the shoulder bands, and an additional horizontal band of retro-reflective tape at the chest front. The garment has a clear plastic ID holder attached, mobile phone pocket, and patch pockets on the front with a side openings. The garment is available in eleven nominal sizes the smallest being XS.


